President John Lawrence opened the meeting, welcoming everyone and running through the order of business.

The President then asked if anyone wanted to comment on the minutes of the 2009 AGM; no one did and those minutes were accepted.

## **President's Report**

It has been a great privilege and an honour to serve as the President of the Criminal Lawyers Association of the Northern Territory, which this year marked its 25 year anniversary of being founded at the Sheraton Hotel. CLANT has remained an active and progressive association during the last 25 years and a special dinner will be held later this year to celebrate the anniversary.

The President noted that he had served as President for the last four years since being elected in 2007 as well as for a previous term of four years beginning back in 1999. Henoted that during that period CLANT has grown considerably, with this year's conference being an outstanding success with the largest ever number of delegates attending. The President has been approached by a number of life members of CLANT who have said that it was the best CLANT conference ever. The conference has traditionally been held at the Bali Hyatt which will be unavailable in 2013 as renovations will be taking place at the time it is usually held and this will pose a challenge for the new committee. The President announced he is retiring as President.

The biggest issue facing CLANT for a long time has been the outrageously disproportionate number of Aboriginal citizens imprisoned in the Northern Territory. Twenty years ago, a Royal Commission headed by Jim Muirhead examined this situation, with many enquiries, much research and hundreds of recommendations having been made to governments in the years since. Twenty years after the Royal Commission the situation is worse. We have gone backwards. As the playersin the criminal justice system we are partly responsible for this. Mandatory sentencing among other things has seen the Aboriginal portion of the prison population rise to almost 80%.

CLANT has campaigned vigorously against the new prison. Unless the rate of imprisonment declines, it will already be filled to capacity when it opens. The money that is being used for the new prison should be going into addressing the causes of crime. Government policy can surely be turned around. Prisons are, in Mike Scuttecky's words, a 'fiscal and moral failure.'

The President thanked the CLANT committee for its assistance and Dee Berkley and Lyn Wild for their hard work organising the conference. Special thanks were made to Jodi Truman for her hard work as Vice President.

The President then invited attendees to raise any general business; nothing was raised.

#### **Election of Committee**

Jodi Truman nominated Mark Johnson as returning officer which was seconded by Robert Welfare.

Mark declared all positions on the committee vacant and emphasised that anyone considering nominating for a position must bear in mind the importance of having the support of the committee.
