## The Uncooperative Victim

Pathways to Victim Protection

## BACKGROUND

C1 – IDENTITY
Aboriginal woman age 19 living in the Greater Darwin Region.
D1 – IDENTITY
Aboriginal male aged 24
Relationship for 5 years

## CYCLE OF VIOLENCE

### **HISTORY OF RELATIONSHIP**

4 years of extreme physical abuse
Geographically & socially isolated
C1 unable to remove herself

## CYCLE OF VIOLENCE

Victim Considerations
Fear
Family & friends
Threats & repercussions
Resignation to situation

## CYCLE OF VIOLENCE

Catalyst for Change
 D1 was imprisoned for other criminal offences

6 months later C1 sought protection

## D1's Criminal Justice Pathway

### Convictions



- Property damage
- Engage in Conduct Contravening DVO (Breach DVO)

### Victims Register



Missed Opportunities – Victim's Register
C1 not provided with info on eligibility
No sentence of imprisonment for Breach DVO
Charge of Aggravated Robbery not pursued

Arrest & Breach of DVO
C1 did not report assault
C1 did not participate in court process
Mandatory sentencing provisions not enlivened

Missed Opportunities
DVO not reviewed
Appropriate charges not pursued
C1 not approached at later date
Referrals not provided

## What Can We Do Better

Awareness of victim considerations
 Approachable when victim is ready
 Referral services
 Exercise options under DV legislation
 Facilitate alternative pathways for victims and defendants
